

PFAS Remark :

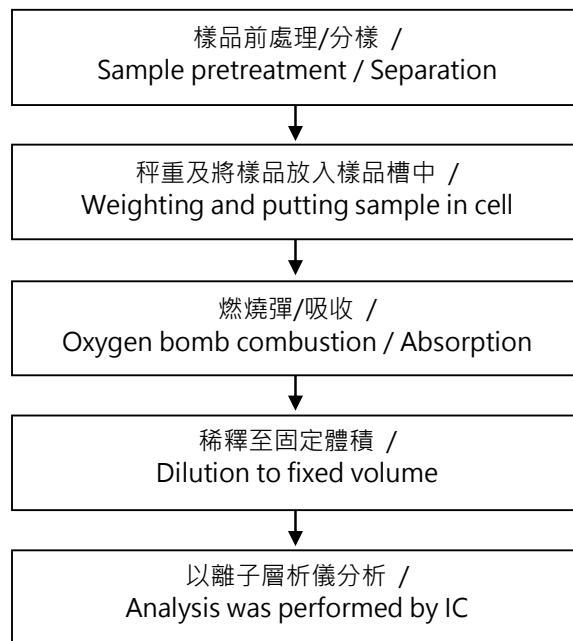

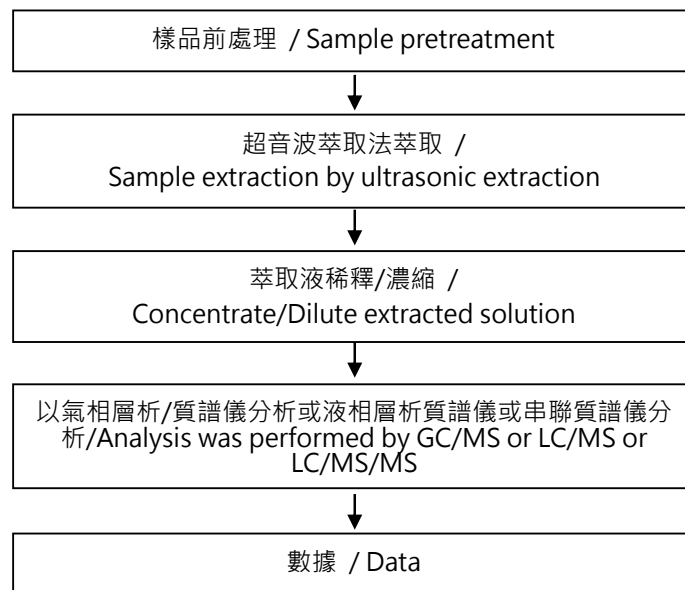

鹵素分析流程圖 / Analytical flow chart - Halogen



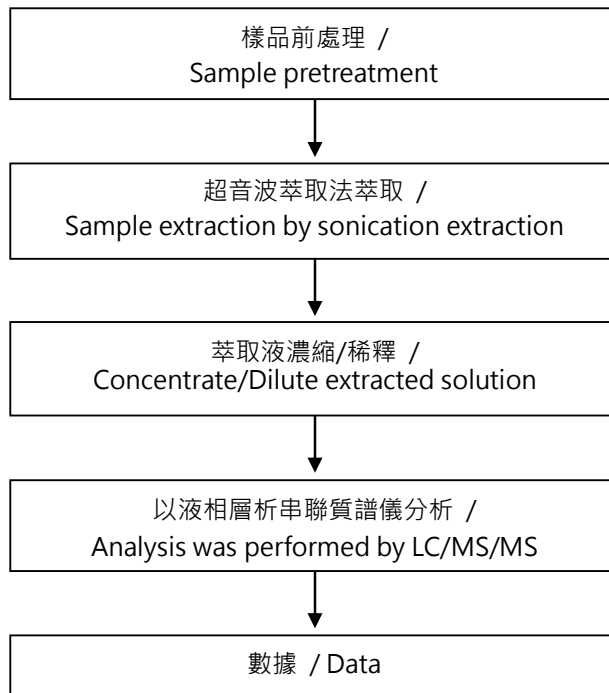

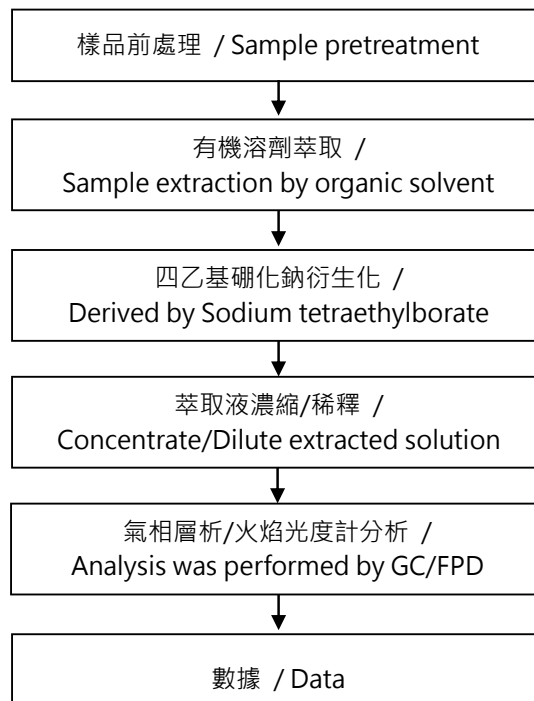

雙酚A分析流程圖 / Analytical flow chart - Bisphenol A



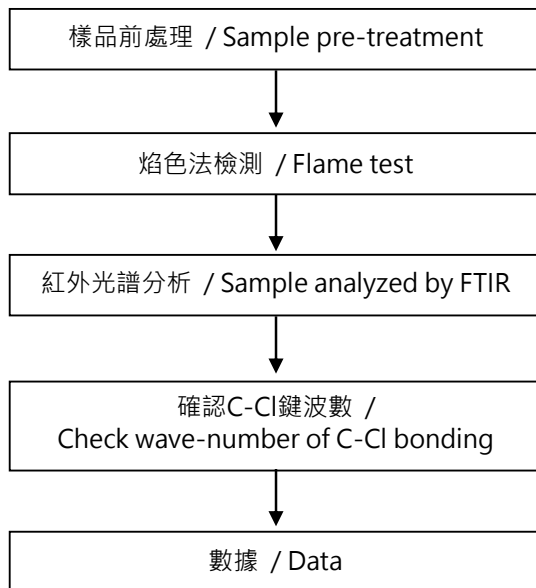

聚氯乙烯物質判定分析流程圖 / Analysis flow chart - PVC



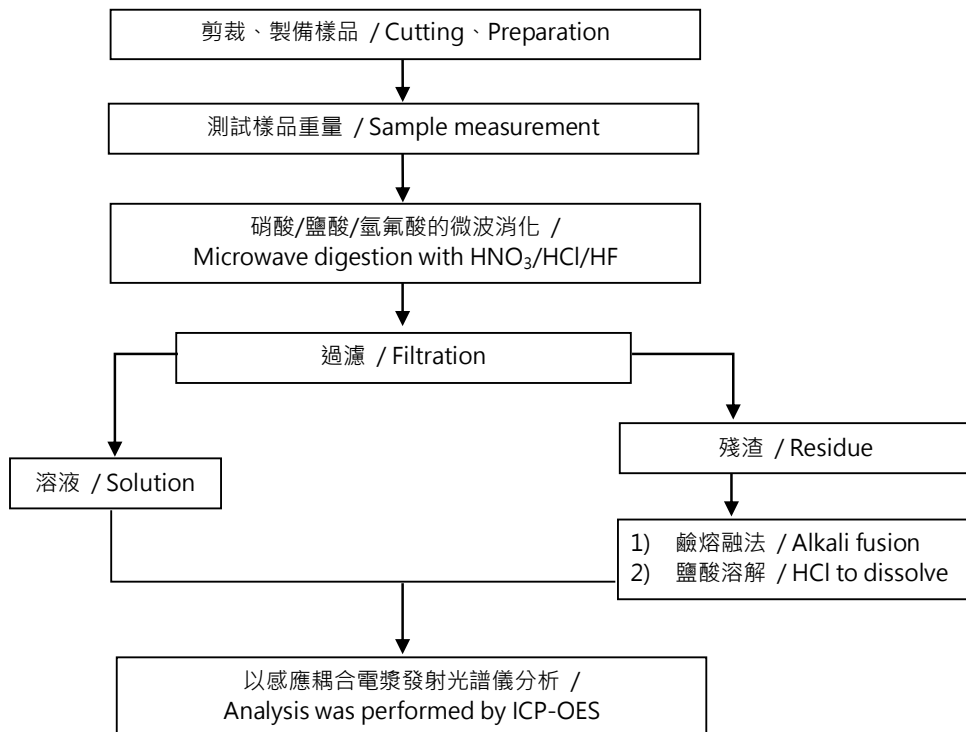

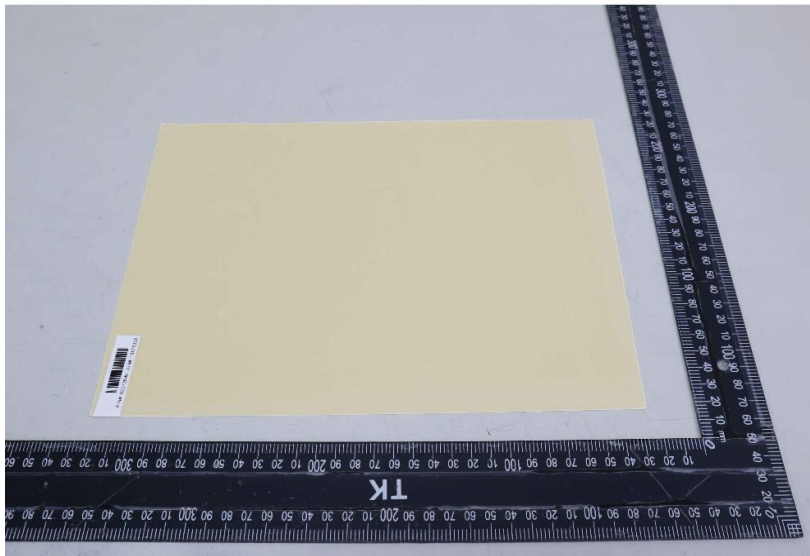
